## **A. Maggie Randazzo, PharmD, BCPS**

*Medical Aid in Dying for the Terminally Ill Act of New Jersey*

Dr. Anne Randazzo ("Maggie") received her Doctor of Pharmacy Degree from the University of the Sciences in Philadelphia in 2011, completed a PGY1 Pharmacy Practice Residency at Shore Medical Center, then practiced at Shore as the Emergency Medicine Pharmacist. Maggie is currently the Pharmacy Clinical Coordinator at Shore Medical Center. In this role, Maggie wears many hats, including serving as the primary pharmacist on the Palliative Care Team, as Co-Chair of the Ethics Committee and as PGY1 Residency Coordinator. In 2018, Dr. Randazzo earned a Six Sigma Green Belt and a certificate in Healthcare Systems Engineering from Lehigh University.

In addition to her role at Shore, Maggie is an Adjunct Professor for the Jefferson University (formerly Philadelphia University) Physician Assistant Program, lecturing in pathophysiology and pharmacotherapeutics and coordinating the Pharmacotherapeutics Seminar course. She also serves as the Southern Chapter Secretary for the New Jersey Society for Health-System Pharmacists.

*If You've Got the Poison, I've Got the Remedy: Current Conundrums in Clinical Toxicology*

Dr. Nadia Awad is an emergency medicine pharmacist at Robert Wood Johnson University Hospital in New Brunswick, NJ. Dr. Awad has authored over 25 peer-reviewed journal articles and research abstracts, and she has presented on topics related to emergency medicine pharmacotherapy and toxicology at several national and regional conferences. Since its launch in 2012, she has been the associate editor of the blog, Emergency Medicine PharmD (<http://empharmd.com>), and she has authored over 75 educational entries related to the application of pharmacotherapy in the emergency department, which currently garners approximately 50,000 views per month from an international audience. **Ofito Iwuchukwu, RPh, PhD**

*Role of Hospital Pharmacists in Orphan and Rare Disease Therapy Management*

Dr. Iwuchukwu is a Pharmacist Scientist with a PhD in Pharmaceutical Sciences from Temple University School of Pharmacy in Philadelphia, Pennsylvania. After her doctoral studies, she proceeded to complete an NIH T-32 pharmacogenomics focused fellowship in Clinical Pharmacology at Vanderbilt University. During her training, she served as chief fellow and was a recipient of the 2015 Clinical Pharmacology Fellows Teaching Award while working locum tenens as a Clinical Pharmacist at Williamson Medical Center in Franklin TN.

Dr. Iwuchukwu is presently an Assistant Professor in the Division of Pharmaceutical Sciences at Fairleigh Dickinson University's School of Pharmacy in Florham Park, New Jersey where she teaches Pharmacogenomics in the core curriculum to third year pharmacy students. She conducts pharmacogenomics research on clinical outcomes for drugs used in cardiovascular diseases and liver transplantation as well as clinical research on rare diseases such as cystic fibrosis. She is an active member of the Clinical Pharmacogenomics Implementation Consortium (CPIC), where she contributes to the consortium's mission of providing guidelines that enable the translation of genetic laboratory test results into actionable prescribing decisions for drugs with validated pharmacogenetic associations. Dr. Iwuchukwu has authored multiple peer reviewed manuscripts and given oral and poster presentations at various national and international meetings. She is an active mentor and representative for women and students and currently serves as Fairleigh Dickinson University Chapter Advisor for Rho Chi, the academic honor society in Pharmacy.

Dr. Iwuchukwu, licensed in Pennsylvania, Tennessee and New Jersey, is currently contributing her clinical skills to patient care as an Investigational Research Pharmacist at St Barnabas Medical Center, a 597 bed academic medical center in Livingston, NJ.
