Immunization Update 2022: "Oh yeah, there ARE non-COVID vaccines"

Anita Siu is a Clinical Professor and Director of Faculty Mentoring at the Ernest Mario School of Pharmacy at Rutgers, The State University of New Jersey. She is a Neonatal/Pediatric Pharmacotherapy Specialist and practices at the K. Hovnanian Children's Hospital at Jersey Shore University Medical Center, a Member of the Hackensack Meridian Health System.

She is also a trained facilitator with the National Research Mentoring Network (NRMN) where she leads workshops and training programs for mentors and mentees across career stages at the School of Pharmacy and Rutgers Biomedical Health Sciences. At the K. Hovnanian Children's Hospital, Dr. Siu is a Board Certified Pediatric Pharmacy Specialist and has created her own clinical practice serving as a liaison between the Department of Pharmacy and Pediatrics. Throughout the years, she has implemented therapeutic guidelines in neonates and pediatrics. Dr. Siu currently leads the Pediatric Pharmacotherapeutics Subcommittee and is a member in many other interdisciplinary committees. Dr. Siu is an advocate for pediatric medication safety and contributes to the literature of neonatal/pediatric pharmacotherapy. Pharmacy Law Update 2022

Angelo Cifaldi is a shareholder with Wilentz, Goldman and Spitzer, P.A., where he is Co-chair of the Mass Tort/ Class Action Team, a member of the management committee and the firm's Vice President. He has been with the firm since he graduated cum laude from Seton Hall Law School in 1984.
