What's This Stuff All About

- Federal Supplemental Reimbursement is part of the Social Security Act Title XIX
- Been around for 30 years
- Not part of Medicaid expansion
- Entitlement program

Why Do We have These Programs?

- Medicaid; Federal, State and Local
- Feds pay the States
- States pay the providers (you)
- Providers shoulder the cost of services (UCC)

How Do They Function?

- These are "cost" programs
- Entire program is based upon the UCC realized by the providers
- Federal Medicaid will share in the cost with the providers to provide the services (50%)

Simple Breakdown - Example

- State Medicaid "Apple Health" pay \$264 per transport
- Provider "cost" of transport is \$1,264
- UCC is \$1,000 (\$1,264 \$264 = \$1,000)
- Federal cost share is 50% = \$500 per transport

Simple Breakdown cont. - Example

- Agency provides 1,500 transport per year
- Medicaid percentage is 18% (agency specific)
- Current reimbursement @ \$264 = \$71,280
- GEMT revenue 270 x \$500
- = \$135,000

• New total

= \$206,280

Drawdown Mechanisms

- Certified Public Expenditures (CPE)
 - Cost report based
- Establishes actual costs (based on the approved program)
 Typically completed annually
- Intergovernmental Transfers (IGT)
 - Can be based on a single rate, rate range, regional rate, etc.
 Is generally not cost report based

 - o Facilitated through agreements/contracts
- Provider Tax

Eligibility

- CPE/IGT must be a unit of Government 42 CFR 433.5
- Allows for contracting (must be through the unit of Government)
- Completely voluntary

How Did We Get Here



- Washington Fire Chiefs became aware of the CA program
- Convened a meeting with WA Chiefs/AP Triton in 2015
- WA Fire Chiefs/Central Pierce facilitated the legislation
- Central Pierce took the lead as the sponsoring agency


Current Status

- Legislation was introduced and signed into law
- Meetings between Stakeholders and State begin
- Informal process begins between WA and CMS
- Initial SPA is submitted

Current Status

- Formal questions and answers begin
- Cost Report/Indirect Cost Rate submitted
- Cost Allocation Plan submitted (CAP)
- Final approval pending

Other States



- WA, OR, MO, KS, NE, AK are in process today with CMS
- ID, OH, WY and MT are considering

- Direct cost, indirect costs, and shared costs

- Phase 2 Program development/SPA
