Code Corner - Traci Harvey, P.E., Spokane Valley Fire Department - SBCC Fire Service Representative

The 2018 code development cycle for the Group 1 codes: IBC, IEBC, IFC & WSEC; is in full swing. The TAG's have been meeting every two weeks for months evaluating the impact of the new model code language on the current WAC's. The final report has been submitted to the SBCC.

New code proposals are being accepted until May 25, 2018. Code proposals need to be submitted through the SBCC website; forms are available through the following link: https://fortress.wa.gov/es/apps/sbcc/page.aspx?nid=7

As code proposals are submitted and the TAG's continuing to meet to discuss the proposals keeping informed about what is happening in the code world is more important than ever. Check the SBCC website for upcoming meeting dates and topics. All TAG meetings are public meeting so all are invited, there are phone-in options and webex connections available. Attending in person is also encouraged, agendas provide locations.

Plan Review Comments - Dave Kokot

When you get involved in plan review, the one thing that you learn quickly is that the code may not be as clear as it should. That is usually due to compromised and consensus language that occurs at Code Hearings. Those are the meetings in which the model code language can be massaged from an original proposal to satisfy the majority of the members voting on it.

So, the plan reviewer may be put into a situation in which an "interpretation" is required. At first glance, that seems to be simple. The plan reviewer looks at the code, looks at the situation, and then declares how the project can come into compliance with the "intent". "Intent" is an interpretation of what the language states. You may also hear another word – "consistency". What may have worked in one case may not work for another. What usually happens is that an "interpretation" sets a precedence. The users of the code apply the interpretation with the prior decision being determined as the direction and path that the plan reviewer had previously accepted a document. So, the plan reviewer needs to consider as many outcomes from the "interpretation" as possible.

There are many resources that can be used to determine the intent of the code (usually the Code Commentary or the Significant Changes handbooks address this), as well as communicating with plan reviewers in your general area. There are also a few plan reviewers from jurisdictions across the State that participate in the Code process as authors or editors. You can also contact ICC or NFPA for their interpretations.

The most important thing that a plan reviewer needs to do, is to provide a clear and concise response. The last thing you want to do is to interpret your interpretation.

If you want to look at a piece of the code that has a number of interpretations, check out the definition for "work area" in the International Existing Building Code. Everyone seems to know what it is, but there is a wide range of answers for that one.

ICC Preferred Provider Documents and Forms

The Washington State Association of Fire Marshals (WSAFM) has long been a supporter of fire prevention professionals in providing educational training credits required for certifications as well as re-certifications. With the recent changes to ICC continuing education units (CEU), WSAFM has entered into an agreement to be a Preferred Provider (PP) through ICC so that CEU credits can be issued through classes sponsored and approved by the Association. This agreement allows members of WSAFM who would like to sponsor training courses to apply for CEU to be issued by the Association. This process involves a two tier process, with approval that may take up to 30-days.
