

## Arson and Explosives

- ATF is the Federal government's "first responder" to fire and explosives incidents
- ATF regulates and inspects the explosives industry
- ATF investigates explosives and fire incidents



## Why Is Arson a Federal Crime?







#### **Authority**

ATF's basic investigative jurisdiction in arson is delineated in 18 United States Code, Chapter 40, Section 844 (Title XI of the Organized Crime Control Act of 1970, as amended by the Anti-Arson Act of 1982); Section 846 and 26 United States Code, Chapter 53 (Title II of the Gun Control Act of 1968, as amended).







## Organized Crime Control Act of 1970 – (aka Explosive Control Act of 1970)

Established Penalties for the misuse of explosives and outlined regulations for the manufacture, importation, sale and storage of explosives





#### Anti Arson Act of 1982



Amended the explosives laws, specifically criminalizing the use of fire to commit any federal felony. The Act made it unlawful to damage or destroy, by fire, any property used in activities affecting interstate or foreign commerce.





#### The Federal Statutes



#### 18 USC 844(i)

Whoever maliciously damages or destroys, or attempts to damage or destroy, by means of fire or an explosive, any building, vehicle, or other real or personal property used in interstate or foreign commerce shall be

- a.Imprisoned for 5-20 years
- b. Imprisoned for 7-40 years
- c. Life in prison or death penalty

■ Title 18 USC 1001 False Statements Up to 5 years

Material false statement or document in matter before U.S.

- Title 18 USC 1341 Mail Fraud Up to 20 years
  Use of mail in scheme to defraud
- Title 18 USC 1343
   Wire Fraud
   Up to 20 years
   Use of wire communications (fax, telephone, etc.) to defraud
- Title 18 USC 1344 Bank Fraud Up to 30 years
   Attempt to defraud financial institution
- Title 18 USC 1956
   Money Laundering Up to 20 years
   Attempt to conceal or change nature of illegally obtained funds
- Title 26 USC 7201 Tax Evasion Up to 5 years
   Attempt to evade or defeat tax imposed



#### National Firearms Act



Laws Passed by Congress in 1934 due to increased violence perpetrated by organized crime throughout the U.S.

Govern the possession and manufacture of machine guns, short barreled weapons, destructive devices, and "any other weapons" – e.g. MOLOTOV COCKTAILS

They must be "registered" with ATF



#### Possession of Unregistered NFA Firearm

It is Illegal to Make, Possess, Transfer, or Receive an Unregistered NFA Firearm

Felony – Up to Five Years

Mandatory Minimum Sentence of 30 Years in Federal Prison if Destructive Device Possessed in Furtherance of Drug Trafficking or Crime of Violence 18 USC 924(c)



## ATF CFI PROGRAM



#### ATF CFI PROGRAM

Two year full-time training program during which special agent candidate must:

Examine a minimum of 100 structural fire scenes
Complete several weeks ATF class room and live burn training
Complete college courses at Oklahoma State University
Conduct research and write a thesis paper on relevant topic
Annual re-certification training & minimum requirements








#### Fire Modeling of Burn Room
















